AN ACT of the County Assembly of Siaya to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending on the 30th June, 2018 and to appropriate those sums for certain public services and purposes

ENACTED by the County Assembly of Siaya as follows—

1. This Act may be cited as the Siaya County Appropriation Act, 2017. Citation.

2. The Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2018, the sum of Kenya Shillings **Six Billion, Five Hundred and Ninety Eight Million, Four Hundred and Fourty Eight Thousand, Five Hundred and Seven** for the services and purposes specified in the Schedule. Issue of KSh. 6,598,448,507 out of the County Revenue Fund for services of the year ending on the 30th June 2018 and the appropriation of the money granted.

3. In addition to the sum granted by section 2, there may be applied, for the several services and purposes specified in the Schedule, the sums specified out of any money directed to be applied as Appropriations in Aid under section 13 (2A) of the Government Financial Management Act, 2004.
