# THE KISUMU COUNTY SUPPLEMENTARY APPROPRIATION ACT, 2020

#### No. 1 of 2020

Date of Assent: 6th March, 2020

Date of Commencement: 16th March, 2020

AN ACT of County Assembly of Kisumu to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the services of the year ending on the 30th June 2020, and to appropriate those sums for certain public services and purposes

**ENACTED** by the County Assembly of Kisumu as follows—

1. This Act may be cited as the Kisumu County Supplementary Appropriation Act, 2020.

Short Title

2. The County Treasury may issue the sum of Kenya Shillings Twelve Billion, Fifty Six Million, One Hundred and Thirty Eight Thousand, Three Hundred and Sixty Eight only out of the County Revenue Fund and apply toward the supply granted for the service of the year ending on the 30th June, 2020.

Appropriation of the Money granted.

**3.** The sum granted by section 2 shall be appropriated for the several services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of that Schedule.

**4.** In addition to the sum granted by section 2, the sum specified in the fourth column of the First and Second Schedules shall be applied for the several services and purposes specified in the second column of those Schedules, out of Revenue directed to be applied outside the County Revenue Fund under Article 207(1) (2) of the Constitution.
