

THE NYAMIRA COUNTY APPROPRIATION BILL, 2020

A Bill for

AN ACT of the County Assembly of Nyamira to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the services of the year ending on the 30th June 2021 and to appropriate that sum for public services and purposes

ENACTED by the County Assembly of Nyamira as follows—

- 1. This Act may be cited as the Nyamira County Appropriation Act, 2020.
- 2. (1) The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending 30th June, 2021, the sum of Kenya Shillings 7,341,614,743 (Seven Billion, Three Hundred and Forty One Million, Six Hundred and Fourteen Thousand, Seven Hundred and Forty Three Shillings only) and that sum shall be deemed to have been appropriated as from 1st July 2020 for the services and purposes specified in the schedule annexed hereto.
- (2) The sum granted out of the County Revenue Fund by subsection (1) as authorized by the Nyamira County Assembly on the 30th June, 2020, in accordance with Article 224 of the Constitution.
