AN ACT of the County Assembly of Kirinyaga to amend certain laws relating to revenue

ENACTED by the County Assembly of Kirinyaga, as follows-

Short title

1. This Act may be cited as the Kirinyaga County Revenue Laws (Amendment) Act, 2018.

Amendment of section 2 of the Kirinyaga County Business Licensing Act, 2014

2. Section 2 of the Kirinyaga County Business Licensing Act, 2014 is amended at the definition of "medium urban areas" by deleting the word Kianyaga.

Amendment of the First Schedule to the Kirinyaga County Business Licensing Act, 2014

- 3. The First Schedule of the Kirinyaga County Business Licensing Act is amended—
 - (a) in Part I at paragraph 1;
 - (i) in item 105 of the table by deleting the expressions "10000", "8000" and "6000" appearing in the first, second and third column respectively and substituting there for the expressions "12000", "10000" and "8000" in the same sequence.
 - (ii) in item 110 of the table by deleting the expressions "5000", "4000" and "3000" appearing in the first, second and third column respectively and substituting there for the expressions "6000", "5000" and "4000" in the same sequence.
 - (iii) in item 115 of the table by deleting the expressions "2500", "2000" and "1500" appearing in the first, second and third column respectively and substituting there for the expressions "3000", "2500" and "2000" in the same sequence.

- (iv) in item 120 of the table by deleting the expressions "2000", "1600" and "1500" appearing in the first, second and third column respectively and substituting there for the expressions "2400", "2000" and "1600" in the same sequence.
