THE THARAKA NITHI COUNTY SUPPLEMENTARY APPROPRIATION ACT, 2018

No. 1 of 2018

Date of Assent: 6th February, 2018

Date of Commencement: 6th February, 2018

AN ACT of the County Assembly of Tharaka Nithi to authorise the issue of sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2018 and to appropriate the sum and the sum voted on account by the County Assembly for certain public services and purposes.

ENACTED by the County Assembly of Tharaka Nithi as follows—

Short title

1. This Act may be cited as the Tharaka Nithi Supplementary Appropriation Act, 2018.

Issue of KSh. 4,632,233,415 out of the County Revenue Fund for the service of the year ending 30th June, 2018.

2. The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2018, the sum of Kenya Shilling Four Billion, Six Hundred and Thirty-Two Million, Two Hundred and Thirty-Three Thousand, Four Hundred and Fifteen and that sum shall be deemed to have been appropriated as from 1st July, 2017.

Appropriation of the money granted

3. The sum granted by section 2 shall be appropriated for the several services and purposes specified in the Second column of the Schedule, in the amounts specified in the Third column of that Schedule.
