THE SIAYA COUNTY APPROPRIATION ACT

No. 1 of 2013

Date of Assent: 30th June, 2013

Date of Commencement: 1st July, 2013

An Act of Assembly of County Government of Siaya to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2014 and to appropriate that sum and a sum voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Siaya, as follows—

This Act may be cited as the Siaya County Appropriation Act, 2013

Short title

(i) The Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2014, the sum of Kenya Shillings four billion One hundred and twenty five million, one hundred thousand, four hundred and thirty nine, and that sum shall be deemed to have been appropriated as from the 1st July, 2013, for the services and purposes specified in the Schedule.

Issue of KSh. 4,125,100,439 out of the County Revenue Fund for service of the year ending on the 30th June, 2014 and appropriation of the money granted

(ii) The sum granted out of the County Revenue Fund by subsection (1) includes the sum of Kenya Shillings four billion, One hundred and twenty five million, one hundred thousand, four hundred and thirty nine voted on account by the County Assembly on the 20th June, 2013, in accordance with article 221 of the Constitution of Kenya.

In addition to the sum granted by section 2, there may be applied, for the several services and purposes specified in the Schedule, the sums specified out of any money directed to be applied as Appropriations in Aid under section 13 (2A) of the Government Financial Management Act, 2004.
