**THE SIAYA COUNTY SUPPLEMENTARY APPROPRIATION
ACT, 2024**

Date of Assent: 24th May, 2024

Date of Commencement: 30th May, 2024

AN ACT of the County Assembly of Siaya to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2024 and to appropriate that sum and a sum voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Siaya, as follows—

Short title

1. This Act may be cited as the Siaya County Supplementary Appropriation Act, 2024.

Issue of KSh. 9,761,123,387 out of the County Revenue Fund for services of the year ending on the 30th June, 2024 and the appropriation of the money granted

2. (1) The Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2024, the sum of **Kenya Shillings Nine Billion, Seven Hundred and Sixty-One Million, One Hundred and Twenty-Three Thousand, Three Hundred and Eighty-Seven only**, and that sum shall be deemed to have been appropriated as from the 1st July, 2023, for the services and purposes specified in the Schedule.

(2) The sum granted out of the County Revenue Fund by section 2 includes the sum of **Kenya Shillings Nine Billion, Seven Hundred and Sixty-One Million, One Hundred and Twenty-Three Thousand, Three Hundred and Eighty-Seven only**, voted by the County Assembly and in accordance with article 221 of the Constitution of Kenya.

Appropriation in Aid

3. In addition to the sum granted by section 2, there may be applied, for the several services and purposes specified in the Schedule, the sums specified out of any money directed to be applied as Appropriations in Aid.
