**THE KIRINYAGA COUNTY EMERGENCY FUND****ACT, 2015**

**AN ACT of the County Assembly of Kirinyaga to provide for the establishment of the Kirinyaga County Emergency Fund and for connected purposes.**

**ENACTED** by the County Assembly of Kirinyaga as follows—

**PART I—PRELIMINARY****Short Title**

1. This Act may be cited as the Kirinyaga County Emergency Fund Act, 2015.

**Interpretation**

2. In this Act, unless the context otherwise requires—

“fund” means the Kirinyaga County Emergency Fund established in Section 3;

“executive Committee Member” means the Executive Committee Member responsible for Finance.

**PART II—ESTABLISHMENT OF THE FUND****Establishment of the Fund**

3. There is established a Fund to be known as the Kirinyaga County Emergency Fund which shall consist of money from time to time appropriated by the County Assembly to the Fund.

**Purpose of the Fund**

4. The purpose of the Fund is to enable payments to be made when an urgent and unforeseen need for expenditure arises for which there is no specific legislative authority.

**PART III—ADMINISTRATION OF THE FUND****Administration of the Fund**

5. In administering the Fund, the Executive Committee Member shall comply with the provisions of the Public Finance Management Act (Cap 412 C).

**PART IV- MISCELLANEOUS PROVISIONS****Regulations**

6. For the purpose of carrying out the objects of this Act, the Executive Committee Member may make regulations on all matters connected with or ancillary to the administration of, the payment of monies into and the withdrawal of monies from, the Fund.

**Transition**

7. The Executive Committee Member shall within thirty days of the coming into force of this Act establish a separate account into which all money appropriated to the Fund shall be paid.
