AN ACT of the County Assembly of Tharaka Nithi to authorise the issue of sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2019 and to appropriate the sum and the sum voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Tharaka Nithi as follows-

Short title

1. This Act may be cited as the Tharaka Nithi County Appropriation Act, 2018.

Issue of KSh. 4,844,778,431 out of the County Revenue Fund for the service of the year ending 30th June, 2019 and appropriation of the money granted

2. The County Treasury may issue out the county revenue fund and apply towards the supply granted for the service of the year ending on the 30th June, 2019, the sum of Kenya Shillings Four Billion, Eight Hundred and Forty Four Million, Seven Hundred and Seventy Eight Thousand, Four Hundred and Thirty One for the services and purposes specified in the Schedule.
