THE MAKUENI COUNTY APPROPRIATION ACT

No. 5 of 2018

Date of Assent; 29th June, 2018

Date of Commencement; 1st July, 2018

AN ACT of the County Assembly of Makueni to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2019, and to appropriate that sum and a sum voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Makueni, as follows—
Short title

1. This Act may be cited as the Makueni County Appropriation Act, 2018.

Issue of KSh. 8,925,859,714 out of the County Revenue Fund and it's application towards the supply granted for the service of the year ending on 30th June, 2019

2. The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2019, the sum of Kenya Shillings Eight billion, Nine Hundred and Twenty Five million, Eight hundred and Fifty Nine thousand, Seven hundred and Fourteen and appropriate it for the services and purposes specified in the Schedule.

Conditional Allocation

- 3. (1) The department of Health services Budget is inclusive of KSh. 200,000,000.00 for Conditional Allocation for Leasing of Medical Equipment, KSh.19,435,760.00 for Conditional Allocations for compensation for User Fees Forgone, KSh. 32,362,139.00 for DANIDA Grant (Universal Healthcare in Devolved System Program) and KSh. 100,000,000.00 for Conditional Allocation Transforming Health Systems for Universal Care Project (WB) appropriated under development budget. The department of Transport and Infrastructure Budget is inclusive of KSh. 187,668,766.00 for Conditional Allocation from Road Maintenance Fuel Levy Fund, appropriated under development budget.
- (2) The department of Agriculture, Livestock and Fisheries Budget is inclusive of **KSh.** 140,435,163.00 for IDA (World Bank) credit (National Agricultural and Rural Inclusive Growth Project and **KSh.** 111,000,000.00 for EU IDEAS LED programme grant Funds appropriated under development budget.

- (3)! The department of Education and ICT is inclusive of KSh. 31,570,000.00 for Conditional Allocation for Development of Youth Polytechnics Funds appropriated under development budget. The department of Finance and Socio Economic Planning is inclusive of KSh. 219,326,286.00 for Conditional Allocation for IDA (World Bank) credit: Kenya Devolution Support Project "grant" Funds appropriated under development budget and The Department of Lands Physical Planning and Mining is inclusive of KSh. 136,261,600.00 for Conditional Allocation for IDA (World Bank) credit: Kenya Urban Support Project Funds appropriated under development budget.
- 3. The sum granted by section 2 shall be appropriated for the several services and purposes specified in the second column of the schedule in the amounts specified in the third column of the schedule.
