THE SIAYA COUNTY APPROPRIATION ACT, 2015**No. 3 of 2015***Date of Assent: 10th July, 2015**Date of Commencement: See Section 2*

AN ACT of County assembly of Siaya to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2016 and to appropriate that sum and a sum voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Siaya, as follows—

1. This Act may be cited as the County Appropriation Act, 2015

Issue of KSh. 6,257,975,264 out of the County Revenue Fund for services of the year ending on the 30th June 2016 and the appropriation of the money granted

2. The Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2016, the sum of Kenya Shillings **Six billion Two hundred and Fifty Seven million, Nine hundred Seventy Five thousand, Two hundred Sixty Four** only, and that sum shall be deemed to have been appropriated as from the 1st July, 2015, for the services and purposes specified in the Schedule.

3. The sum granted out of the County Revenue Fund by subsection (1) includes the sum of Kenya Shillings **Six billion Two hundred and Fifty Seven million, Nine hundred Seventy Five thousand, Two hundred Sixty Four** only, voted on account by the County Assembly on the 29th June, 2015, in accordance with article 221 of the Constitution of Kenya

4. In addition to the sum granted by section 2, there may be applied, for the several services and purposes specified in the Schedule, the sums specified out of any money directed to be applied as Appropriations in Aid under section 13(2A) of the Government Financial Management Act, 2004.

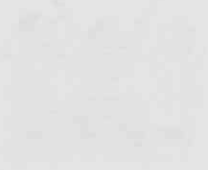
