# THE NYERI COUNTY FLAG AND OTHER SYMBOLS BILL, 2020 Bill for

AN ACT of the County Assembly of Nyeri to give effect to Section 4 of the County Governments Act, 2012 and for the development and use of the County flag, County Coat of Arms and County Public Seal and, to prevent the improper use of the County symbols and for connected purposes

**ENACTED** by the County Assembly of Nyeri, as follows—

#### PART I-PRELIMINARY

#### **Short Title and Commencement**

1. This Act may be cited as the Nyeri County Flag and Other Symbols Act, 2020 and shall come into operation upon publication in the County Gazette and the Kenya Gazette.

#### Interpretation

2. In this Act—

"County Assembly" means County Assembly of Nyeri;

"County Coat of Arms" means the County Coat of Arms as declared under section 5(2);

"County Executive Committee" means Nyeri County Executive Committee;

"County Executive Member" means the County Executive Committee Member responsible for Public Administration;

"County Flag" means the County Flag as declared under section 5(1);

"County Government" means Nyeri County Government;

"County Public Seal" means the County Public Seal as declared under section 5(3);

"County symbols" means the County Flag, the County Coat of Arms and the County Public Seal as declared under section 5;

"Gazette" means a Kenya Gazette or County Gazette published by the authority of the County Government or a supplement of such Gazette;

"specified likeness" means any photograph, drawing or other pictorial representation of the person for the time being holding any of the offices specified in section 10.

Custody and use of County symbols

#### Purpose of the Act

3. The purpose of this Act is to regulate the use of the County Flag, the County Coat of Arms, and County Public Seal and any other symbol developed pursuant to Section 4 of the County Governments Act, 2012.

#### Application

4. La This Act shall apply to Nyeri County as established pursuant to Article 6(1) and the First Schedule to the Constitution.

#### County Flag, Coat of Arms, Public Sea and Other Symbols, declared

- 5. (1) The County flag, of which the design and description are set out in Part 1 of the Second Schedule of this Act is hereby declared to be the County Flag of Nyeri County.
- (2) The heraldic device of which the Blazon and description are set out in Part II of the Second Schedule of this Act is hereby declared to be the County Coat of Arms of Nyeri County.
- (3) The seal of which the design is set out in Part III of the Second Schedule of this Act is hereby declared to be the County public seal of Nyeri County.

#### **Disrespecting a County Symbol**

6. Any person who shows disrespect, in speech, manner or writing, to or with reference to the Nyeri County Flag, or to any specified symbol, or any representation thereof, shall be guilty of an offence and liable to a fine not exceeding KSh. 100,000, or to imprisonment for a term not exceeding six months, or to both such fine and such imprisonment.

#### Alteration of, use, display or dishonouring of County Flag

- 7. (1) A person shall not—
- (a) without lawful authority, alter the County Flag by the placement thereon of any letter, emblem, or representation;
- (b) in or within view of any public place, use, display, destroy, or damage the County Flag in any manner with the intention of dishonouring it.
- (2) The authority to develop county symbols shall vest in the County Executive Committee.
- (3) Any person who contravenes sub-section (1) commits an offence and shall be liable, on conviction to a fine not exceeding KSh. 100,000 or to imprisonment for a term not exceeding six months, or to both.

#### Custody and use of County symbols

- 8. (1) The office of the County Secretary shall be the custodian of Symbols and shall by regulation made by the County Executive Member, prescribe the fee at which County symbols, other than the County Public seal, may be made available for use by the public.
- (2) County Symbols shall not be used except with the permission of the County Executive Member and in the manner prescribed in the regulations.
- (3) No authority shall register any company, firm or other body of persons or any trade mark or design or grant a patent where such registration or grant of patent would violate the provisions of this Act.
- (4) Any registration made or patent granted in violation of this provision shall be null.
- (5) No person shall keep within his premises or display at any place or on any premises or permit to be so kept or displayed any item or imitation with the intention of portraying it as the symbol of the County if the same was not developed as such symbol in the manner provided under this Act.
- (6) The County Executive Member shall, by regulation, specify the places at which and the manner by which the County symbols shall be used or displayed.

#### Flying of County flag on a motor vehicle only now and A

- 9. (1) A person shall not fly the county flag on any motor vehicle except as provided for under this Act.
- (2) Notwithstanding subsection (1), the Governor, Deputy Governor and the Speaker may fly the County flag on their official motor vehicles.
- (3) A person who contravenes subsection (1) commits an offence and shall be liable on conviction to a fine not exceeding Kenya Shillings 30,000 or to imprisonment to a term not exceeding 6 months or both.

#### Hoisting of the County Flag

- 10. (1) Subject to this Act, the County Flag shall be hoisted on the following occasions and places—
  - (a) in official functions that is attended by the Governor, Deputy Governor and the Speaker of the County Assembly or their representatives;
  - (b) In all intergovernmental forums where Nyeri County is represented;

- (c) at the Headquarters of the County Government;
- (d) at the County Assembly;
- (e) at the head offices of Sub-Counties, Wards and Villages;
- (f) at the Liaison offices of County Governments;
- (g) At the Offices of Members of the County Executive Committee;
- (h) at the official residence of the Governor, Deputy Governor and the Speaker;
- (i) at the ward Offices of the Members of County Assembly;
- (i) at all County public facilities.
- (2) The County Executive Committee Member may prescribe such other occasions and places where the County Flag shall be hoisted or displayed.

#### Salutations

- 11. The salutations within the County are as follows—
- (a) The Governor and any visiting Governor shall be referred to as His/Her Excellency the Governor;
- (b) The Deputy Governor and any visiting Deputy Governor shall be referred to as His/Her Excellency the Deputy Governor;
- (c) The Speaker of the Assembly and a visiting Speaker of another County Assembly shall be referred to as the Honourable Speaker;
- (d) The Member of County Assembly and a visiting Member of another County Assembly shall be referred to as Honourable Member of County Assembly;
- (e) The Member of the County Executive Committee and any visiting County Executive Member of another County shall be referred to as the County Executive Committee Member.

#### PART III—MISCELLANEOUS

#### General offence and Penalty

12. Any person who contravenes any provision of this Act in which no penalty is provided for, shall be guilty of an offence and shall be liable, on conviction, to a fine not exceeding fifty thousand shillings or to imprisonment for a term not exceeding three months or to both.

#### Power to amend

13. The County Executive Member may, by notice in the Kenya Gazette or County Gazette whichever comes earlier, amend the Second Schedule to this Act to add any symbol or name as a county symbol and to which this Act shall apply.

#### Regulations

- 14. (1) The County Executive Member may make regulations generally for the better carrying out of the objects of this Act.
- (2) Without prejudice to the generality of sub-section (1), the Regulations may—
  - (a) prescribe the places and occasions upon which, the persons by whom and the manner in which the County Flag may be flown or displayed, as the case may be;
  - (b) prohibit, control or restrict the use of any County symbol or specified likeness;
- (c) prescribe for the manner in which application for permission under section 8 may be made and prescribing the form of any license by which such permission may be given and fixing any fee for such application and license.

(b) The Deputy Governor and any visiting Deputy Governor shall be referred to as His/Her Excellency the Deputy Governor.

 The Speaker of the Assembly and a visiting Speaker of another Crunty Assembly shalf be reterred to as the Honourable Speaker;

(d) The Member of County Assembly and a visiting Member of another County Assembly shall be referred to as Henourable Member of County Assembly:

(e) The Member of the County Executive Committee and any ostung County Executive Member of mother County shall be reforred to as the County Executive Committee Member.

#### PART III — MISCEELANEOUS

General offence and Penalty

12. Any person who continuences any provision of this Act in which no penalty is provided for shall be guilty of an offence and shall be finable, on conviction for a function exaceding lifty thousand shillings or to imprisonment for a term not exaceding three mentils or to both.





## MEMORANDUM OF OBJECTS AND REASONS

- 1. The principal object of this Bill is to provide for the enactment of legislation prescribing for the county symbols listed below as provided for under section 4 of the County Government Act:
  - (a) The county flag;
  - (b) County coat of arms; and 1
  - (c) The county public seal.
  - 2. The Bill-
  - (a) provides for the protection of the County Symbols;
  - (b) imposes sanctions on any person who disrespects the County Symbols;
  - (c) prohibits improper use of symbols.
- 3. The Bill does not delegate legislative powers nor does it limit any fundamental rights and freedoms.
- 4. The Bill is a County Government Legislation for it gives effect to section 4 of the County Government Act.
- 5. This Bill is not a money bill within the meaning of Section 114 of the Constitution and Section 21 of the County Government Act.
