AN ACT of the County Assembly to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2023 and to appropriate that sum for certain county public services and purposes.

ENACTED by the County Assembly of Laikipia, as follows-

Short title

1. This Act may be cited as the Laikipia County Supplementary Appropriation (No.2) Act, 2023.

Issue of KSh. 338,251,385 out of the County Revenue Fund for service of the year ending 30th June 2023.

2. The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2023, the sum of Kenya Shillings Three Hundred and Thirty Eight Million, Two Hundred and Fifty One Thousand, Three Hundred and Eighty five only. That sum shall be deemed to have been appropriated as from 1st July, 2022, for the services and purposes specified in the Schedule.

Conditional Grants and Pending Bills

3. In addition to the sum granted by section 2, there may be applied, for the several services and purposes Specified in the Schedule, the sums specified out of any money directed to be applied as Conditional Grants and Pending Bills Under Article 138 (6) (a) and 136(2) respectively of the PFM. Act (2012).

Appropriation of the money granted

4. The sum granted by section 2 and 3 shall be appropriated for the several services and purposes specified in the second column of the schedule in the amount specified in the third column of the schedule.
