### THE SAMBURU COUNTY COMMUNITY HEALTH SERVICES ACT, 2021

AN ACT of County Assembly of Samburu to provide for establishement and recognition of Community Health Volunteers and their role in health care system and for other connected purposes

ENACTED by the County Assembly of Samburu, as follows-

### PART I-PRELIMINARY

### Short title

2021

1. This Act may be cited as the Samburu County Community Health Services Act, 2021 and shall come into force on publication in the Gazette.

### Interpretation

2. In this Act, unless the context otherwise requires -

"County" means the Samburu County:

"County Community Health Services Committee" means a County Committee established under part IV of this Act;

"Community health committee" means a community health committee established under section 16 of this Act:

"Community health assistant" means a community health assistant appointed as such under this Act as per section 23;

"Community health Officer" means a community health officer appointed as such under this Act as per section 23;

"Community health plan" means a plan for community-based health services prepared by the community health committee for the improvement of the health care of the community units or households:

"community health services" means the package of basic health care services provided to people in their communities and households and includes-

(a) health education:

health promotion; (b)

disease prevention and control; (c)

- (d) mental health and psychosocial support services;
- (e) public health services;

(f) emergency health and referral or linkage services;

- (g) sensitization on addictions;
- (h) home care;
- (i) long term care;
- (i) rehabilitation services;
- (k) palliative care and minor treatment for illness; and
- (1) injury in relation to primary health care.

"community health unit" means an area within the County health structures comprising of a cluster of villages which make up a sublocation as defined under the Samburu County Village Delicanation Act, 2015 or as may from time to time be designated by the County Executive Committee Member;

"Community Health Volunteer" means a person selected by the community based on set criteria defined by this Act and has undertaken relevant training to offer health services at the community level; free services;

"County Executive Committee Member" means the County Executive Committee Member for the time being responsible for matters relating to health and sanitation;

"health facility management committee" means the existing committees managing link facilities;

"management committee" means a management committee established pursuant to this Act;

"Sub-County Community Health Services Committee" means the committees as already established at the sub-county level to oversee delivery of community health services;

"village" means a people with same socio-economic characteristics living together and/or moving together within Samburu County and shall be in clusters of households to be determined from time to time.

"household" means a group of people living together in one house and cooking from the same pot;

"health Technologies" means application of organized knowledge and skills in form of devices, medicines, vaccines, procedures and systems developed to solve health problems and improve quality of health.

### **Guiding Principles**

3. The application of this act shall be guided by the following principles -

- (a) equity in distribution of health services and interventions;
- (b) people-centered approach to health and health interventions;
- (c) efficiency in application of health technologies;
- (d) participatory approach to delivery of interventions;
- (e) multi-sectoral approach to realizing health goals; and
- (f) social accountability.

### **Objects and Purpose of the Act**

- 4. The objects and purpose of this Act is to-
- (a) give effect to the provisions of Article 176(2) of the Constitution and Section 48 of the County Governments Act 2012;
- (b) provide for the establishment of community health units within the County for the effective delivery of community health services;
- (c) create the necessary institutional and coordination frameworks to encourage and facilitate the provision of community health services;
- (d) protect the health and safety of community health volunteers;
- (e) provide for rights, duties and responsibilities of relevant officers and partners within the community health sub-sector;
- (f) gather evidence or information on community health to inform decision-making at community level;
- (g) coordinate and streamline financial contributions from partners and well-wishers for community health services;
- (h) provide for the management of the Community Health Services; and
- (i) develop capacity of community health volunteers, community health officer and community health assistant.

### PART II-DUTIES AND RESPONSIBILITIES

### **Duties and Responsibilities of County Government**

5. The county government shall provide health care services to every person who is a resident of the County, and shall –

(a) ensure that the County residents' right to basic health as provided for under Article 43 of the Constitution are progressively realized subject only to the availability of resources;

- (b) establish policies and mechanisms to ensure that residents of the county households are educated and informed on matters of healthy living and practices;
- (c) ensure that every household has access to a community health officer/assistant or a community health volunteer; and
- (d) provide advisory services and guidance, through community health extension and volunteer health services, to persons in need of healthcare information.

### **Duties and Responsibilities of Household**

6. Every household within a community health unit is responsible for ensuring that the appropriate health practices are effected and shall—

- (a) participate in community-organized health activities;
- (b) attend and participate in meetings that are aimed at educating the people on best health practices and for disseminating information or feedback to the people;
- (c) implement behavioural changes that are aimed at improving individual, households and community health;
- (d) collaborate and cooperate with community health volunteers in promoting health within the community and eliminating health risks through strategies set and implemented by the County Community Health Services Committee; and
- (e) provide relevant data and information to the community health volunteers to collect data and information for the purpose of informing policy decisions at distinct levels of governance.

### PART III-ESTABLISHMENT OF COMMUNITY HEALTH UNITS

### Establishment of Community health Units

7. (1) There is established Community Health Units in the County for ease of delivery of Community Health Services.

(2) On recommendation of the Community Health Services Committee, the County Executive member for Health shall use existing villages, total population, number of households and area in square kilometers as provided for in the Samburu County Community Health Strategy Projections in the First Schedule as a basis for the determination 2021

of the initial number of community health units per Sub County as well as the number of community health volunteers per community health unit.

(3) There shall be an initial recognize 108 Community Health Units as set out in the Second Schedule.

(4) a community health unit shall comprise not more than twenty villages and a village shall comprise at most one hundred households.

(5) There shall be such a number of Community Health Volunteers in each Community Health unit may as from time to time be prescribed by the County Community Health Services Committee.

### Link facilities

8. Each Community Health Unit shall be linked to a health facility as provided for in the Second Schedule, provided that this may be amended by the County Executive Committee Member from time to time as need arises.

### PART IV—SAMBURU COUNTY COMMUNITY HEALTH SERVICES COMMITTEE

### **County Community Health Services Committee**

**9.** (1) There is established a Samburu County Community Health Services Committee.

(2) The County Community Health Services Committee shall comprise of -

- (a) the chairperson to be appointed by the County Executive committee member;
- (b) the chief officer responsible for health;
- (c) County Community Health Services coordinator who shall be the secretary and *ex-officio* member;
- (d) two person representing faith-based health organizations;
- (e) two representatives from health development partners; and
- (f) three persons representing special interest groups (Youth, women, PWD) who shall be an active Community health volunteer and registered with their respective bodies.

### **Eligibility for appointment**

- 10. (1) Chairperson-
- (a) should have at least certificate in health related field from a recognized institution; and

(b) has at least Five years experience.

(2) Other than persons provided for in section 9(2)(b) (c) a person is qualified to be appointed as a member of the Committee if the person—

- (a) satisfies the requirements of Chapter Six of the Constitution of Kenva, 2010 and the Leadership and Integrity Act; and
- (b) is not disqualified under any other written law.

### Term of office

11. (1) Except for persons who are members by virtue of their office, a member of the Committee shall hold office for a term of three years and may be re-appointed for one further term.

(2) The office of member of community health services committee shall fall vacant when a member—

- (a) resigns from office in writing addressed to the CECM;
- (b) is convicted of a criminal offence;
- (c) is declared bankrupt; or
- (d) dies.

(3) A vacancy in the office of community health committee member shall be filled within a period of at most three months.

Roles and Responsibilities of the County Community Health Services Committee

12. (1) The Committee shall be responsible for the coordination of community health services in the County.

(2) Without prejudice to the generality of sub section (1), the Committee shall—

- (a) recommend development of policies to ensure that there are adequate measures to cater for the provision of community health services in all parts of the county;
- (b) oversee and monitor the implementation of community health services within the county and report to the Executive Committee Member in a manner prescribed by regulations;
- (c) develop strategies for effective and efficient delivery of community health services;
- (d) advise the Executive Committee Member responsible for Health on matters of community health;

- (c) resource mobilization for additional funding for community health services delivery from donors and other development partners; and
- (f) perform any other function as may be assigned under any law or by the Executive Committee member.

### Meetings for the community health services committee

13. (1) The Committee shall meet at least once every three months.

(2) The quorum for the Committee sittings shall be at least two thirds of all members.

(3) The Committee shall cause proper records to be kept of all proceedings of the committee.

(4) Except as provided under this part, the committee shall regulate its own meetings.

(5) Notwithstanding the provisions of subsection (1), the chairperson may, and upon requisition in writing by at least four Committee members convene a special meeting of the committee at least once in a quarter for the transaction of the business of the committee.

### **County Community Health Technical Working Group**

14. (1) The County Executive Committee member shall establish a County Community Health Technical Working Group which shall have the mandate of implementing the policies and guidelines of the Community Health Services.

(2) The County Community Health Technical working group shall comprise of —

- (a) County Director of preventive and promotive Health; who shall be the Chairperson;
- (b) the County Community Strategy Coordinator; who shall be the secretary;
- (c) County Public Health Officer;
- (d) County Health Promotion Officer;
- (e) representatives from community health services Partners;
- (f) County Nutrition Officer;
- (g) County Pharmacist;
- (h) County Nursing Officer;
- (i) County Health Records and Information Officer;

County Reproductive Health Coordinator; and (i)

(k) the committee May co-opt any members if need arise.

(3) The County Executive Committee Member shall establish Sub-County Community Health Technical Working Groups in each of the sub counties in the County, which shall report to the County Community Health Technical Working Group and have the mandate of implementing the policies of the County Community Health Services.

(4) Sub County Community Health Technical Working Groups shall comprise of -

- (a) Sub County Medical Officer for Health, who shall be the Chairperson:
- (b) Sub-County Community Strategy Focal Person who shall be the secretary;
- (c) Sub County Public Health Officer;
- (d) Sub County Health Promotion Officer;
- (e) representatives from Partners;
- Sub County Nutrition Officer; (f)
- (g) Sub County Pharmacist;
- Sub County Nursing Officer;
- Sub County Health Records and Information Officer;
- Sub County Reproductive Health Coordinator; (i)

(5) The County Executive Committee Member shall make regulations to govern the affairs of the County and Sub County Community Health Technical Working Groups.

### Roles and responsibilities of the Community Health Technical working group

15. The functions of the Community Health Technical working group Committee. shall be as may be prescribed by the County Executive Committee Member and shall include providing technical guidance for purposes of preparing the community health plan.

### The Community Health Committee

16. (1) There is established for every Community Health Unit a Community Health Committee.

(2) The Community Health Committee shall comprise of -

- (a) the community health officer and or assistant, who shall be the
- (b) the assistant chief appointed under the National Government Coordination Act, with jurisdiction over the relevant community health unit;
- (c) the village administrator appointed under the Samburu county village unit delineation act 2015;
- (d) one person representing the health facility management committee who shall be the chairperson;
- (e) two persons, one from either gender, nominated by religious organizations;
- (f) one community health volunteer, from either gender, who shall be the treasurer to the committee; and
- (g) one community member representing persons with disabilities.

#### **Eligibility for appointment**

secretary;

- 17. A person is eligible to serve in the committee if the person-
- (a) has been resident in the village unit and has shown provable intention to reside in the unit throughout the period of service; and
- (b) is of good moral standing in the community.

### **Term of Office**

18. (1) Except for persons who are members of the community health committee by virtue of their office, a member of a community committee shall serve for a term of three years and is eligible to serve for one further term of three years.

(2) The office of member of community health committee shall fall vacant when a member-

(a) dies;

(b) resigns from office in writing addressed to the chairperson; or

(c) is convicted of a criminal offence.

(3) A vacancy in the office of community health committee member shall be filled within a period of three month.

### Meeting of the Committee

19. (1) The committee shall meet at least once a month and at any other such time as the committee may deem necessary for the performance of its functions.

(2) A meeting of the community health committee shall be properly constituted if attended by at least two thirds of all its members.

### Roles and responsibilities of the community health committee

- 20. (1) The functions of the community health committee are to-
- (a) identify community health priorities through regular dialogue with the community and stakeholders;
- (b) plan and participate in community health actions;
- mobilize resources for community health actions; (c)
- (d) organize and implement community health days;
- (e) make periodic or other reports to the County Community Health Services committee in such manner and on such matters as may be prescribed by regulations;
- (f) lead community health outreach and campaign initiatives;
- promote practices and activities that enhance good health in the (g) community;
- (h) participate in selection of community health volunteers; and
- (i) do such other things as may be prescribed or required by the County Executive Committee Member for health.

(i) (2) In the performance of its functions, the Community Health Committee shall report to the link facility management committee.

### **Community Health Plan**

21. (1) A community health committee shall develop a community health plan for each fiscal year and shall share it with the Health Facility Management Committee,

- (2) The community health work plan shall include-
- (a) recommended priorities for the delivery of community health services;
- (b) a demonstration that the recommended priorities have been established through community consultation;

- (c) provisions identifying and making recommendations for elimination of duplicity in the delivery of community health services.

(3) Sub-County health management committees shall make available to the community health committee such information as may assist the community health committees in assessing the financial feasibility of implementing the recommendations.

(4) Sub-County health management teams shall ensure that community health plans are developed by the relevant community health committees and considered in the preparation of the health services plan.

(5) The Executive Committee Member shall ensure that Community Health Plans are developed by County Community Health Services Committees and considered in the preparation of the Health Services business plan.

### PART VI-COMMUNITY HEALTH VOLUNTEERS

### Nomination of Community Health Volunteers

22. (1) There shall be nominated by members of the community a community health volunteer for every village in a public meeting convened by the community health officer or community health assistant with the assistance of the area chief and village administrator who has jurisdiction over the relevant area.

### **Eligibility of Community Health Volunteers**

23. A person qualifies to be nominated as a community health volunteer if the person-

- (a) is a Kenyan citizen who is eighteen years and above;
- (b) has been a resident of relevant village in the community health unit;
- (c) is generally accepted by the local community as an honest and upright citizen; and
- (d) able to speak the language of the predominant local community.

### **Responsibilities of Community Health Volunteers**

- 24. A community health volunteer shall-
- advise individuals or members of households within the community health unit on healthy living practices;

- (b) provide first aid and treatment of minor illness and conditions with the support and guidance of a community health officer and or Assistant:
- (c) refer cases to the link facility for further medical attention ;
- (d) visit households to provide guidance on individual or public health issues;
- (e) maintain a village health register and keep records of all community health-related events;
- (f) promote good reproductive health practices within households:
- participate in community quarterly dialogue days and monthly (2) actions days;
- (h) keep relevant records and submit reports to the community health officer and or assistant;
- (i) perform any other role that may be assigned by the community health officer and or assistant.

### Scope of Community Health Volunteer Operations

25. A Community Health Volunteer shall serve under the general direction and guidance of the relevant Community Health officer and or assistant.

### Number of households assigned to a Community Health Volunteer

26. A Community health officer and or assistant shall assign to a Community Health Volunteer such number of households within the community health unit as shall be prescribed by regulations.

#### **Prohibited** acts

- 27. (1) A community health volunteer shall not-
- (a) administer to a member of a community medication that is not authorized by the ministry of health;
- (b) conduct deliveries for pregnant women;
- (c) negligently mishandle property entrusted to them for the purpose of delivering services to the community; use tools, gadgets or properties under their custody for purposes other than delivery of volunteer health services;
- (d) solicit financial or other reward for personal gain whether or not in recognition of effort in delivering services to the community;
- (e) falsify any records or data collected in the course of duty; or

Samburu County Community Health Services (f) engage in other activities that may conflict with the provision of community health services.

(ii) (2) Any community health volunteer who contravenes the provisions of this section shall be subject to disciplinary sanctions which may include termination of service by the community health services committee including prosecution under the laws of Kenya.

### **Training of Community Health Volunteers**

28. (1) Every community health volunteer shall undergo relevant training as prescribed by ministry of health.

(2) The County Community Health Technical Working Group shall-

- co-ordinate and facilitate the training of Community Health (a) Volunteers:
- (b) engage partners with a view to securing partners' support in the facilitation of training of Community Health Volunteers;
- (c) may prescribe additional requirements relating to training of community health volunteers.

### **Removal from Service**

29. (1) The services of a Community Health Volunteer may be terminated on any of the following grounds-

- (a) failure to submit their monthly reports for 3 consecutive months as per the Act;
- (b) failure to perform their duties and responsibilities as outlined in this Act;
- breach of terms of service or a code of conduct established (C) under this Act: or

(d) inability to render services due to physical or mental incapacity.

(2) A Community Health Volunteer may resign from service by one month's written notice addressed to the secretary of the relevant community health committee.

#### **Committees financial records and reports**

30. (1) The Committee shall cause to be kept proper books of accounts of the income, expenditure, assets, liabilities and all other financial transactions of the committee.

(2) The Committee shall submit quarterly reports to the Executive Committee member.

(3) Within 30 days after the end of each fiscal year, the Committee shall prepare financial statements and submit the financial statements to the County Auditor's Office for audit in accordance with the provisions of the Public Audit Act, 2003.

### PART VII-MISCELLANEOUS

### Regulations

No. 4

31. (1) The County Executive Committee Member may make regulations generally for the better carrying out of the objects of this Act.

(2) The County Executive Committee Member shall establish mechanisms to provide for the health services needs of mobile and under privileged populations.

(3) The County Executive Committee Member may by regulations provide for the alteration of the boundaries of a Community Health Unit. if need arises, and for the registration of new Community Health Units.

(4) The County Executive Committeee member shall make such regulations prescribing monthly renumeration mechanisism for Community Health Volunteer The payment shall be performance based.

### **Identification Documents**

32. The County Executive Committee Member shall prescribe and afford the Community Health officer/assistant and Community Health Volunteers proper means of identification.

### Savings and Transitions

33. A person who served as a Community Health Volunteer before the coming into force of this Act may be re-appointed in accordance with the provisions of this Act.
