Date of commencement: 1st July, 2020

AN ACT of the County Assembly of Turkana to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2021 and to appropriate that sum and a sum voted on account by the County Assembly for Certain public services and purposes

**ENACTED** by the County Assembly of Turkana, as follows —

#### Short title

**1.** This Act may be cited as the Turkana County Appropriation Act, 2020.

# Issue of KSh. 15,032,757,284.00 out of the Consolidated Fund for service of the year ending 30th June, 2021 and appropriation of the money granted

2. The Turkana County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the services of the year ending on the 30th June, 2021, the sum of Kenya Shillings Fifteen Billion, Thirty Two Million, Seven Hundred and Fifty-Seven Thousand, Two Hundred and Eighty-Four only and that sum shall be deemed to have been appropriated as from 1st July, 2020, for the services and purposes specified in the schedule (2).

**3.** In addition to the sum granted by section (2), there may be applied, for the several services and purposes specified in the schedule, the Sums specified out of any money.
